1. The permission accorded does not confer any ownership rights, At a later stage if it is found that the documents are false and fabricated the permission will be revoked U/s 450 of GHMC Act 1955.
2. If construction is not commenced within 6 months, building application shall be submitted afresh duly paying required fees.
3. Sanctioned Plan shall be followed strictly while making the construction.
4. Sanctioned Plan copy as attested by the CMC shall be displayed at the construction site for public view.
5. Commencement Notice shall be submitted by the applicant before commencement of the building U/s 440 of GHMC Act.
6. Completion Notice shall be submitted after completion of the building & obtain occupancy certificate U/s 455 of GHMC Act.
7. Occupancy Certificate is compulsory before occupying any building.
8. Public Amenities such as Water Supply, Electricity Connections will be provided only on production of occupancy certificate.
9. Prior Approval should be obtained separately for any modification in the construction.
10. Tree Plantation shall be done along the periphery and also in front of the premises.
11. Tot-lot shall be fenced and shall be maintained as greenery at owners cost before issue of occupancy certificate.

34. Structural Safety and Fire Safety Requirements shall be the responsibility of the Owner, Builder/ Developer, Architect and St. Engineer to provide all necessary Fire Fighting installations as stipulated in National Building Code of India, 2005 like;
- a) To provide one entry and one exit to the premises with a minimum width of 4.5mts. and height clearance of 5mts.
 - b) Provide Fire resistant swing door for the collapsible lifts in all floors.
 - c) Provide Generator, as alternate source of electric supply.
 - d) Emergency Lighting in the Corridor / Common passages and stair case.
 - e) Two numbers water type fire extinguishers for every 600 Sq.mts. of floor area with minimum of four numbers fire extinguishers per floor and 5k DCP extinguishers minimum 2 Nos. each at Generator and Transformer area shall be provided as per I.S.I. specification No.2190-1992.
 - f) Manually operated and alarm system in the entire buildings;
 - g) Separate Underground static water storage tank capacity of 25, 000 lts. Capacity.
 - h) Separate Terrace Tank of 25,000 lts. Capacity for Residential buildings.
 - i) Hose Reel, Down Corner.
 - j) Automatic Sprinkler system is to be provided if the basement area exceeds 200 Sq.mts.
 - k) Electrical Wiring and installation shall be certified by the electrical engineers to ensure electrical fire safety.
 - l) Transformers shall be protected with 4 hours rating fire resist constructions.

m) To create a joint open space with the neighbors building / premises for maneuverability of fire vehicles. No parking or any constructions shall be made in setbacks area.

General Conditions

1. The owner / developer of the site shall ensure that the C&D; Waste generated is transferred only to the designated C&D; Waste Collection point , **Jeedimetla Circle 55** of the proposed site duly paying the requisite fee to the agency at the transfer as per the quantity arrived.

Additional Conditions

1. The applicants shall handover the areas covered under roads, open spaces and social infrastructure to CMC through a registered gift deed before release of permission at the time of Occupancy Certificate.
2. The applicant is the whole responsible if any discrepancy occurs in the ownership documents and ULC aspects and if any litigation occurs, the technically approved building plans may be with-drawn without any notice.
3. The applicant/ developer are the whole responsible if anything happens/ while constructing the building.
4. If any cases are pending in court of law with regard to the site U/R and have adverse orders, the permission granted shall deem to be withdrawn and cancelled.
5. The CMC reserve the right to cancel the permission, if it is found that the permission is obtained by false statement or misinterpretation or suppression of any material facts or rule.
6. The Owner/Developers shall be responsible for the safety of construction workers.

Proceedings Conditions:

1. The applicant shall submit Water Feasibility Certificate before coming for Occupancy Certificate. 2. The peripheral road should be open for general public
